# RESOLUTION # 129 APPROVAL OF MINUTES

A motion was made by Trustee Astry to approve the minutes of July 26, 2023, with the following corrections: Trustee Cruver's Report – She reported she will be calling Dan Pacos not that she left a message. Trustee DuBois's Report – She reported that the sign LED lights have a 5 year warranty, not that the sign hadn't worked in 5 years, seconded by Trustee Cruver. VOTE: 5 AYES, 0 NAYS.

## **GUESTS:**

Robert Frank Jr., Fire Chief Cassadaga Volunteer Fire Department, stated that the Cassadaga Fire Department would like the Village of Cassadaga to purchase two sets of Firefighter Turnout Gear out of their annual budget line for gear. One set had been ruined at a past fire and another set was no longer fit for active duty. The department was reimbursed for a portion of the costs of the gear from the neighboring Fire District where the gear was ruined. The cost for each set of turnout gear is \$3,021.60. The department would contribute the \$1,622.70 they were reimbursed, so the remaining cost would be \$4,420.50.

He also reported that the Beach Drill was a success between the firefighters and the beach staff. The department would like to have the Rescue Boat docked at the beach during the summer months to ensure faster response times if needed. The board agreed that would be a great idea. If it's docked at the beach would need to make sure there's posted signs to stay off and it will be under video surveillance. Will also need to look into covering it as well. The department and the board of trustees will work together to come up with a plan for next year.

  have been requested and the staff is working on setting up a yearly
  certification for both CPR & First Aid to help control costs
- The beach has had an ongoing bee problem so she has purchased another garbage can with a lid to try and help with bee control
- She wanted to thank all of the beach staff and the volunteers for the hard work they did recently at the beach. The beach crew stayed after their shifts ended to work with volunteers Chris & Thadeus Wichlacz who took time off work as well to install the grills, the message board, and the bench on the beach grounds
- There was \$312.00 extra left from funds raised for the bench which was donated to the Waldameer Beach Trip
- She reported the basketball lock is missing requested Sam install new from stock if he has one
- She asked if Sam had looked into getting 50-amp service for Ames Common for food trucks. Trustee Astry reported that it may be possible after looking it over just need to come up with a plan
- She also noted problem with the erosion on Lakeview Avenue and asked if gravel placement could possibly stop some of this from happening

- She reported that it has been brought to her attention on numerous occasions that there is a large puddle that pools when it rains on Park Avenue that the residents would like fixed if possible
- She also stated that there is room in the Deputy Clerk Budget Line to pay Roxanne Astry for the work she did on the Tree Inventory Grant
- She noted that the house located at 72 Lakeview Avenue appears to be an unsafe structure and the Code Enforcement Officer has sent letters with no action being taken by the owner to correct
