

Dear Mayor Dorman,

This letter is in response to your municipal zoning referral received in full by this office on August 15th, 2023 regarding the adoption of a local law to regulate short-term rentals in the Village of Cassadaga.

As one of the designated staff to the Chautauqua County Planning Board, I have reviewed the above noted referral to the County since it is within 500 feet of State Road Route 60, County Road CR 58, CR 71, CR 72, and a municipal boundary. The proposed local law would affect the R, B, I, and C Zoning Districts.

I have reviewed the pertinent inter-community and county-wide considerations with respect to this proposal and its effect on the relevant concerns that are listed under General Municipal Law 239-1. Based on this review, I find that the proposed action would have no significant countywide or inter-community impact and that the proposal would be a matter of local concern.

However, in order to help the Village with its decision, I offer the following informal comments:

- I applaud the Village for proposing a local law to set standards and regulate short-term rentals. Short-term rentals are not a new concept, however popularity has increased over the last decade. Preparing for and developing local regulations for this concept can help suit your locality's needs. Short-term rentals within a municipality can help to increase tourism, incentivize development, and help to generate revenue.
- The Town of Canadice has developed a short-term rental law which has been recognized as a model law for other municipalities to consider. The Village may wish to review this model law and include additional language and regulations that are specific and detailed.
- 3. The Village may wish to review and consider the case law of *Hignell-Stark v. City of New Orleans*. In Hignell-Stark v. City of New Orleans, the Court held that the "primary residence" requirement violated the U.S. Constitution's dormant Commerce Clause, which prohibits states and local governments from restricting interstate commerce¹. An important takeaway from this case is that it may not be in the best interest of municipalities to propose short term rental laws that impose an owner-occupied or residency requirement, unless, the locality can demonstrate that a legitimate public purpose exists for which there is no discriminatory alternative.

- 4. In the proposed law, Section E (5) states "Pre-existing recognized STRs, as defined in Section H, shall be counted towards the initial cap." However, Section H (1) seems to contradict this by stating "Recognized pre-existing STR owners shall be afforded the opportunity to apply for a STR permit and not subjected to the cap limitation if they meet all the following requirements within thirty (30) days of this law taking effect". It is recommended that the Village reviews the language in both sections to ensure that the intent of the proposed law is clearly stated.
- 5. The New York Planning Federation (NYPF) offers a one hour webinar titled *Regulating Short-term Rentals in Your Jurisdiction*, which the Village may be interested in referencing. - 6. The Village may wish to review its comprehensive plan to ensure that short-term rentals are covered in the plan. If short-term rentals are included in the plan and zoning regulations are in accordance with the plan, then this may provide the Village with solid legal ground if the law were to ever be challenged.

Wilson Endurance Sports brought a total of 440 athletes to the community between February and September of 2023. Athletes were registered to visit Cassadaga from the following 14 states and Canada; AL, CA, GA, FL, IN, MA, MI, NJ, OH, PA, SC, TX, VA, WV, and all over NY State from as far as Saratoga Springs, NYC, Syracuse and the Hudson Valley.

The Town of Pomfret was concerned with the high number of runners on the roadways so we canceled the Cassadaga Lakes Running Festival that was scheduled for May. They did permit us to continue the CassadagaMan Triathlon over Labor Day with increased signage warning motorists.

The parking for all summer events was successfully held at the Johnny Fessenden Ball Fields. This ensured that parking was open for the church, the Fire Hall, and the uptown businesses. We offered a shuttle to bring spectators and participants to the park and this continues to go very welt. For any planned training bike rides we asked cyclists to park in our yard so as not to have cars sitting all morning in any of the above-mentioned locations as well as the park.

Several athletes traveled from as far as Cleveland, OH, Pittsburg PA, and Syracuse, NY to take part in training days. Many spending their money at local AirBnB establishments, eating in our restaurants, shopping, etc. here in Cassadaga.
