MAYOR DORMAN'S REPORT Updates:

- I sent an e-mail to Joe Pagan regarding collaboration with Job Corp. on the bath house.
 - He responded and had Mr. Grace send an e-mail that didn't sound real encouraging but will get in touch before the BOCES fall term begins.
- Followed up with Paul Mihalko regarding any BOCES graduates that might consider the Utility/Laborer position.
 - "Hard to compete."
 - "I have a female graduate with a CDL starting at \$70/hour. I'll put it out there again. Many of my students are starting at \$20/hour or better".

- She reported that we need to transfer money from water checking to Reserve for Debt Service for future Capital Project with excess not used.
- The tax warrant is prepared to be approved ordering Clerk/Treasurer Annette McChesney to collect taxes.
- She reported that members of the County Planning Board will meet with us and do a walk through of our properties and make recommendations.
- She is also working on a grant from Urban Forestry for tree inventory and management.

SUPT. OF PUBLIC WORKS SAM ALAIMO REPORT-Absent

- Trustee Astry reported that Sam has Well # 5 back in service and it was inspected by County on Tuesday with aeration system improvement.
- Received quote from NYS agency Source Well for salt shed repairs.
- The Johnny Fessenden ballfield sign was put up on Monday. Trustee Astry
 has spoken with Kathy Fessenden Webster, and she will be coming to NY
 end of June, and we can set dedication after talking with her. He also stated
 that there is a 2-foot space under the sign that event banners can be placed
 that are at ballfield. This sign was a result of bed tax grant that Trustee
 Flaherty wrote.
- He reported that him and Sam broke into hot dog stand and put a new lock on the door. There is baseball equipment in there and a sign that states that it was donated by Post 1280 Legion for Little League teams.

TRUSTEE ASTRY'S REPORT-

• Gave a report from CVFD. 3 EMS calls, 10 calls dispatched and cancelled on route, 4 MVA, 1 CO call, 4 power lines down, 1 fire, 1 brush fire, 1 standby, 25 calls Total, 118.92 manhours.

TRUSTEE FLAHERTY'S REPORT

- A zoom meeting was held with CLA members on the Goose removal program on May 18th.
- CAP walk had 95 participants and Maple Avenue Academy helped.
- The deadline to put up solar lights is June 1st.
- Grills need to be put up at beach and wondering if she could hire someone.
- She wants to thank the 11 volunteers who helped plant flowers, weed and spread mulch at Ames Common.
- Job Corp will paint the benches at the park.
- She and Cathy will interview lifeguards on May 31st.
- Farmer's Market will open up on May 28th at Ames Common.
- Cruise Night at Legion is May 30th.
- She thanked Clerk Astry for everything she has done for the village and stated that residents have no idea what is involved and what you have done. She made reference on the big grant for refinance loan and methane removal project that saved us 1.5 million dollars.

TRUSTEE CRUVER'S REPORT

 She reported that the County Planning Board will direct us on where we could apply for grant money in many categories. We should have a vision from the residents and see what they would like. She would like to see our main priority be our water system. As stated, before that Dale Drive and Main Street still need waterline replacement and we need new meters, so we do not lose revenue on old meters.
