John Sipos: Village Historian addressed the board about the Labor Day Parade and activities over the Labor Day Weekend. Bob Reuther also discussed the drainage problem on Dale Drive and Park Avenue and when it rains hard foreign material flows into the lake and the Lakes Association is concerned about this. Route 60 is draining into the ditch and with heavy rain it over flows.

Tammi Wichlacz; Beach Director. She reported that we had inspection done by Chautauqua County Health Department and had on minor violations that have been taken care of. The water tests have come back fine.

She is getting things ready for the Beach Carnival and will have Smokey the Clown, Carnival Games, dump tank, bounce house or slide. The kids are excited about it and everyone is having good time at beach.

CLERK-TREASURER ASTRY REPORT:

- Reported that she completed the Audit Report for the State Comptroller's office and offered her books for audit to the board.
 She stated that Bahgat & Laurito will be doing the audit for the last two years as is required for our Capital Project.
- Reported that Notice of Petition of Samuel Violanti and Judith Violanti versus Town of Stockton and Assessor was received in the matter of the application under Article 7 of the Real Property Tax Law.
- Reported that payment was made to USDA Rural Development in the amount of \$109,850.68 for first principal and interest payment for our loan. Another interest payment of \$46,237.50 will be paid Feb. 1, 2015.
- The Standard Work Day Resolution has to be made for Joshua Slaven. It was determined after submission of reported 3 month Record of Activities hours worked to amount to an average of .95 per month will be calculated for time.
- Lime Energy on behalf of National Grid did audit of our lights at the DPW building. It was determined that estimated annual savings would be \$1,422.30 if we replaced the lights that they suggest. Estimated Job Cost is \$5,035.23 with National Grid contribution of \$2,941.61 and our cost \$2,093.62. This could be paid in lump sum of \$1,817.08 (15% savings), \$174.47 12 month payment, or \$87.23 over

- 24 months. A discussion was held and it was decided to research further before decision made.
- Reported that we received one quote for compost pile and that we should see if we can get another one.
- Septic System was discussed.
