The regular meeting of the Village of Cassadaga was held on August 21, 2013 with Mayor LeeAnn Lazarony presiding. Trustees present were Jeffrey Frick, Mike Lehnen, Valerie Culverwell, and Ron DeChard. Also in attendance were Attorney Mike Benedict and Deputy Clerk Angelica Martin.

RESOLUTION #122

APPROVAL OF MINUTES

Motion made by Trustee Lehnen, second by Trustee Culverwell to approve the minutes of August 7, 2013 minutes. VOTE: 4 AYES, 0 NAYS.

RESOLUTION #123 ACCEPT AGENDA

A Motion was made by Trustee Culverwell to approve the agenda, second by Trustee DeChard. VOTE: 4 AYES, 0 NAYS.

GUESTS: Tim Ode

Tim Ode, owner of property on Putnam Road requested water service for two of his properties; 7522 Putnam and 7510-12 Putnam Road. He was informed that 7510-12 will require two water meters if they are separate apartments. He was also asked to put in separate meter at his property with two apartments on 17 Maple Avenue.

RESOLUTION # 124

APPROVE NEW WATER SERVICE ON PUTNAM ROAD

Trustee Lehnen moved, second by Trustee Culverwell to approve new water service on property owned by Tim Ode. This will consist of 1 water service at 7522 and 2 water services at 7510 and 7512. Two tapping fees will be charged with additional costs for materials. VOTE: 4 AYES, 0 NAYS.

ATTORNEY MIKE BENEDICT REPORT:

- Further discussion is needed for North Shore Park waterline. We will call Engineer Greg McCorkhill after meeting for clarification.
- He reviewed letter from Chautauqua County Executive Gregory Edwards. The County is forming a land bank to combat community deterioration by facilitating the return of vacant, abandoned, and tax delinquent properties to productive use. As part of Shared Highway Service agreement among the County local governments they are adding a Waiver of Landfill Tipping Fees for C&D Waste. Each participating town and village will receive an annual credit for tipping fees of 80 tons of C&D waste, including asbestos containing materials at the County landfill. After reviewing the provisions he recommended the board adopt the C&D Waster Addendum.
- Discussed the issue of accumulated vehicles and trash in an Industrial District. He advised to have Zoning Enforcement Officer send letter to property owner.

- He reviewed our Peddler's Local Law and noted that there is a provision for charitable fundraising and advises no further action be taken.
- Parking on Park Avenue was discussed and different options were reviewed. Trustee Culverwell will ask residents if they would object to having Park Avenue a One Way street during beach season.

RESOLUTION # 125

APPROVE C&D WASTE ADDENDUM TO COUNTY SHARED SERVICE Trustee Culverwell moved, second by Trustee Frick to approve the Shared Highway Services C&D Waste Addendum. We will be allowed an annual credit for tipping fees of 80 tons of C&D waste including asbestos containing materials for demolition of deteriated or vacant, abandoned buildings. VOTE: 4 AYES, 0 NAYS.

- Reported that approval is needed for Pay Apps for both Kandey Company and Ahlstrom Schaeffer for Contract 5 & 6.
- Form E # 20 needs approval for total expenditures to date of \$3,221,690.39.
- Announced that the Cassadaga Branch Library will have Open House on newly renovated building from 11AM to 4PM on Friday, August 30, 2013.
- Samples for the new treatment plant were chosen: Roof; ash gray, snow guards; ash gray, gutter; brown.

- Mill Street needs to have "Children at Play" signs put up.
- Reported that they had drill with Fredonia and the water they drew from hydrant on Mill Street was dirty. Mayor Lazarony reminded him that the fire department has been instructed to fill tanker at pump house so it doesn't rile up the water on Mill Street. It was also stated that if they are filling pools clerk needs to know who is receiving it and log is supposed to be kept when the Firemen fill the tanker.

The carnival proceeds will benefit Captain Dave's Cruise for Special Needs children and children of Veterans serving. The summer beach program has went very well this year and did a number of drills with the fire department.
- She reported that she spoke with County Youth Director Patti Yokum regarding our beach program. They want us to serve free lunches during our program because it isn't considered a Recreation Program if this does not occur and we are technically not eligible for state funding. We have to do a lot of paper work and reporting to them to get the funds of only \$300 and recommends that we do not apply for them.
- She thanked Tom and Garrett for putting posts on dock because it has helped with geese problem.

Trustee Lehnen had to leave for emergency.
