INTRODUCTION

To comply with State regulations, the Village of Cassadaga annually issues a report describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and awareness of the need to protect our drinking water sources. Last year, your tap water met all State drinking water health standards. We are proud to report that our system did not violate any maximum contaminant levels or any other water quality standard. However, we failed to monitor for Lead and Copper, which is discussed in the section "Is our water system meeting other rules that govern operations?"

This report provides an overview of last year's water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards.

WHERE DOES OUR WATER COME FROM?

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include: microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Our water system serves approximately 635 people through 365 service connections, along with the Lily Dale Assembly and the Cassadaga Job Corps Center. Our water source consists of three groundwater wells – well #1, well #4 and well #5. Well #5, the newest well, is treated by aeration to remove methane. Blended orthophosphate (Carus 8100) is added to the water from well #4 and #5 to reduce discoloration (brown water) caused by naturally occurring iron and manganese. Finally, chlorine is added to our water before it is pumped into the distribution system.

The NYS DOH has completed a source water assessment for Wells #1 and #4 based on available information. Possible and actual threats to this drinking water source were evaluated. The state source water assessment includes a susceptibility rating based on the risk posed by each potential source of contamination and how easily contaminants can move through the subsurface to the wells. The susceptibility rating is an estimate of the potential for contamination of the source water, it does not mean that the water delivered to consumers is, or will become contaminated. While some inorganic contaminants were detected in our water, it should be noted that all drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants from natural sources. The presence of contaminants does not necessarily indicate that the water poses a health risk. See section "Are there contaminants in our drinking water?" for a list of the contaminants that have been detected.

The source water assessment has rated our wells 1 and 4 as having a medium susceptibility to microbials, nitrates, industrial solvents, and other industrial contaminants. There has not been an assessment done on well #5. These ratings are due primarily to the close proximity of permitted discharge facilities (septic systems that discharge wastewater into the environment and are regulated by the state and/or federal government) to the wells and the associated activity in the assessment area. The wells draw from a confined aquifer. A copy of the assessment can be obtained by contacting us as noted above.

ARE THERE CONTAMINANTS IN OUR DRINKING WATER?

As the State regulations require, we routinely test your drinking water for numerous contaminants. These contaminants include: total coliform, inorganic compounds, nitrate, nitrite, lead and copper, volatile organic compounds, and synthetic organic compounds. The table presented below depicts which compounds were detected in your drinking water. The State allows us to test for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, are more than one year old. It should be noted that all drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Notes:

- 1- The level presented represents the 90th percentile of the 10 sites tested for lead from 9/22 to 9/24. A percentile is a value on a scale of 100 that indicates the percent of a distribution that is equal to or below it. The 90th percentile is equal to or greater than 90% of the Lead values detected at your water system. In this case 10 samples were collected at your water system and the 90th percentile value was calculated to non-detectable. There were no levels of copper detected in any of the ten sites sampled.
- 2- The level presented represents the 90th percentile of the 10 sites tested for copper on 9/22 to 9/24. Again the 90th percentile value was calculated to be equal the second highest result value for Copper which was 0.423 ug/l. The action level for Copper was not exceeded at any of the sites tested.
- 3- The NYSDOH considers 50 pCi/l to be the level of concern for beta particles.

Definitions:

<u>Maximum Contaminant Level (MCL)</u>: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible.

<u>Maximum Contaminant Level Goal (MCLG)</u>: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

<u>Maximum Residual Disinfectant Level (MRDL)</u>: The highest level of a disinfectant that is allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

<u>Maximum Residual Disinfectant Level Goal (MRDLG)</u>: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

<u>Action Level (AL)</u>: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Non-Detects (ND): Laboratory analysis indicates that the constituent is not present.

<u>Milligrams per liter (mg/l)</u>: Corresponds to one part of liquid in one million parts of liquid (parts per million - ppm).

<u>Micrograms per liter (ug/l)</u>: Corresponds to one part of liquid in one billion parts of liquid (parts per billion - ppb).

Picocuries per liter (pCi/L): A measure of the radioactivity in water.

WHAT DOES THIS INFORMATION MEAN?

During state assisted sampling in 2018 conducted every three years, we detected the presence of 1,1,1-Trichloroethane in well #1. A resample of well #1 in October 2018 again resulted in a detection of the contaminant. Therefore, sampling for this contaminant was performed quarterly in 2019. We continued to detect 1,1,1-Trichloroethane in well #1 during quarterly monitoring, however all detects were below the designated MCL's. We have now been moved to yearly monitoring to continue surveillance of these contaminants.

The New York State Health Department has provided us the specific health effects as follows:

Some people who drink water containing 1,1,1-Trichloroethane in excess of the MCL over many years could experience problems with their liver, nervous system, or circulatory system.

We have learned through our testing that some contaminants have been detected; however, these contaminants were detected below the level allowed by the State. Lead and copper were detected within the system but of the 10 samples collected none were found exceeding the action levels. We are however required to present the following information on Lead in drinking water:

If present, elevated levels of lead can cause serious health problems, especially for pregnant women, infants, and young children. It is possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing. The Village of Cassadaga is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. IS OUR WATER SYSTEM MEETING OTHER RULES THAT GOVERN OPERATIONS?

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During 2019, our system was in compliance with applicable State drinking water operating and reporting requirements, but not monitoring. We were issued one violation for not monitoring our water for lead and copper. Therefore, we cannot be sure of the quality of our water for these contaminants last year. We will be conducting lead and copper sampling in 2020 and will notify you immediately if there is a problem.

DO I NEED TO TAKE SPECIAL PRECAUTIONS?

Although our drinking water met or exceeded state and federal regulations, some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care

WHY SAVE WATER AND HOW TO AVOID WASTING IT?

Although our system has an adequate amount of water to meet present and future demands, there are a number of reasons why it is important to conserve water:

- Saving water saves energy and some of the costs associated with both of these necessities of life;
- Saving water reduces the cost of energy required to pump water and the need to construct costly new wells, pumping systems and water towers; and
- Saving water lessens the strain on the water system during a dry spell or drought, helping to avoid severe water use restrictions so that essential fire fighting needs are met.

You can play a role in conserving water by becoming conscious of the amount of water your household is using, and by looking for ways to use less whenever you can. It is not hard to conserve water. Conservation tips include:

- Automatic dishwashers use 15 gallons for every cycle, regardless of how many dishes are loaded. So get a run for your money and load it to capacity.
- Turn off the tap when brushing your teeth.
- Check every faucet in your home for leaks. Just a slow drip can waste 15 to 20 gallons a day. Fix it up and you can save almost 6,000 gallons per year.
- Check your toilets for leaks by putting a few drops of food coloring in the tank, watch for a few minutes to see if the color shows up in the bowl. It is not uncommon to lose up to 100 gallons a day from one of these otherwise invisible toilet leaks. Fix it and you save more than 30,000 gallons a year.

CLOSING

Thank you for allowing us to continue to provide your family with quality drinking water this year. Tom Fetter continues as our Consultant with a Class C Water License. Both Sam Alaimo and Robert DeGolier have passed the Class C Water Operator Course and Robert DeGolier received his Class C Water Operator License.

The rate structure will continue with a \$ 95.00 debt service per dwelling unit and a water rate usage of \$ 4.50 per thousand gallons beginning June 1, 2020. The December 1, 2020 billing will reflect the increase of \$.50 per 1000 gallons usage. Partial payments will be accepted by the Village Clerk with total to be paid within 60 days; henceforth after that date a Shut Off notice will be issued. Any unpaid water bills in arrears over nine months as of April 1st shall be included in the annual tax levy. Water billings go out on June 1st and December 1st.

Spring clean up will be until May 25th with leaves and grass clippings only. Limbs and branches only will be picked up the following week left at curbside with our wood chipper. Summer clean up of leaves/grass clippings and limbs/branches will be picked up June 1st, July 6th and August 3rd. Fall clean up will be on Mondays weather permitting.
