**APPROVAL OF AGENDA**

Tim Cobb reported that he had worked with Attorney Haylett on the bid specs for restoration of Engine 101. Board members reviewed the specs that Attorney Haylett had sent. FERN DERBY MEMORIAL FOR BEACH PROGRAM

WHEREAS, Fern U. Derby, a former Village resident, passed away on November 21, 2016 in Sanford, North Carolina, and

WHEREAS, Ms. Derby was an active member of the Village community having volunteered for PTA, Girl and Boy Scouts and she was a leading voice in establishing the Cassadaga Beach Program, and

WHEREAS, the family of Ms. Derby requested that monetary donations be made to the Cassadaga Beach Program in lieu of flowers, and

WHEREAS, the Village has received \$600 in donations from the family and friends of Ms. Derby, and

WHEREAS, Village Law Section 1-102 authorizes a Village to accept private moneys donated for specific purposes, now therefore

BE IT RESOLVED, that the board of Trustees of the Village of Cassadaga hereby accepts the monetary gifts made in honor of Fern U. Derby in the amount of \$600, and be it further

RESOLVED, that the accepted funds be deposited in the Trust and Agency account of the Village and be used towards the Village of Cassadaga Beach Program, and be it further

RESOLVED, that the Village does hereby extend its sincere sympathies to the family of Ms. Derby and deepest appreciation for this generous memorial.

**RESOLTUION #183** 

WAIVE VILLAGE RESIDENCY REQUIREMENT FOR DEPUTY VILLAGE CLERK

Mayor Lazarony moved, second by Trustee Kalfas to pass the following Resolution; VOTE 4 AYES, 0 NAYS.

WHEREAS, there has existed a vacancy in the position of Deputy Village of Cassadaga for over 6 months, and

WHEREAS, no interested candidates that are residents of the Village of Cassadaga have applied to the vacancy, and

WHEREAS, due to the lack of interest in the Deputy Village Clerk position, the Village desires to expand the permitted residency requirement for the Deputy Village Clerk to any resident of the County of Chautauqua, State of New York, now therefore be it

RESOLVED, that pursuant to Village Law Section 3-300 and New York State Attorney General Opinions, the Board of Trustees of the Village of Cassadaga, New York hereby waives the Village residency requirement for the position of Deputy Village Clerk; and be it further RESOLVED, that the Board of Trustees will accept applications from any qualified resident of the County of Chautauqua, State of New York for the position of Deputy Village Clerk.

# CLERK-TREASURER ASTRY REPORT:

- Reported that Fiscal Advisors has sent an amendment to their Service Agreement by adding Appendix C-Disclosure of Conflicts of Interest.
- She would like permission to make 2 water adjustments on billing. Eliminate Joe Spayer's water bill 1607510-1 at 7510 Putnam Road Apt. 1 for \$167.00. The service was taken out and made into a one family house instead of 2 and I billed it in error. Ralph Potter of 269 Maple Avenue bill was estimated high because she did an estimated reading with the assumption that 2 people were living there and in fact they just moved in. Actual usage was 7,000 gallons instead of 21,000 and would like to adjust \$56.00.
- Would like permission to transfer \$43,651.41 from Debt Service to Water checking to cover the cost of the Methane Removal Project.
- She reported that we have received \$600 for the beach program in memory of Fern Derby. She read letter from Marcia (Lawson) De LaCerda who was the first female beach director from 1966-1970 and has very fond memories of Fern Derby.
- She reported that the DWSRF loan from EFC will be closing on January 9<sup>th</sup> instead of January 5<sup>th</sup>. She received email and spoke with representative that it may be a few days past that because of a delay in a PACB meeting. She was advised to hold check for \$38,860.60 to Rural Development for interest to date because it may have to be for more. EFC will pay the balance of loan to Rural Development and after we submit request for Methane Removal System they will transfer money to our Debt Service account.
