ATTORNEY'S REPORT-Absent

MAYOR LAZARONY'S REPORT:

- She reported that Attorney Haylett will have resolution for next meeting for accepting donations in the name of Fern Derby for beach program.
- Reported that she attended the Cassadaga Job Corp Tree Lighting and it was very nice. She spoke with director and asked if they would allow sledding at the Job Corp during the Winter Festival. She will send letter requesting this.
- She reported that received letter from Arthur Nist's wife to let us know that he passed away on November 23rd. He was a past Town of Stockton Supervisor and loved this area.
- She reported that she wrote letter to the US Post Office asking for longer hours to get pick up mail. They have asked the landlord to replace windows in front and make handicap accessible. They are also looking for other buildings to have Post Office.

CLERK-TREASURER ASTRY REPORT:

- Reported that she chose level debt for our DWSRF loan with a principal payment of \$126,100 for the next 30 years. The interest payments to USDA Rural Development have been around \$88,000 to \$92,000 annually the last couple of years which we will not have to pay any longer.

TRUSTEE ASTRY'S REPORT:

He received quote from DFT Security Services for CO detectors and smoke detectors for each of the buildings; Water Tank and Booster Station installation of \$299 and monthly monitoring of \$41.90, Water Treatment building and Methane Removal building installation of \$399 and monthly monitoring of \$41.90, DPW building and Pump House 1 and 2 installation of \$1,200 and monthly monitoring of \$25.95 and CO detectors at Fire Hall/Community Building installation of \$600 with monthly monitoring to be included in current fire monitoring. Currently we only have fire detector at fire hall and no CO detectors in any of the building that is required by state law.
