#### **CLERK-TREASURER ASTRY REPORT:**

- She reported that she completed the DEC Annual Water Withdrawal and our percentage of water loss has went down. It has been determined that there are no leaks and old water meters can run slow and not all water recorded that is used. We try to replace some each year.
- We received the Audit Report back from Bahgat & Laurito-Bahgat for Fiscal Year ending May 31, 2017. There were no discrepancies and overall a clean audit. They suggest that the board continues to approve and review journal entries.
- Suggested that the board review the description of Public Works Superintendent and revise it to meet the village's needs.
- Suggested that the board determine at tonight's budget meeting what they will be offering applicants for Supt. of Public Works and Utility Worker.

**DEPUTY CLERK BONITA MAZZONE: No report** 

SUPERINTENDENT OF PUBLIC WORKS TOM FETTER: Absent.

#### TRUSTEE KALFAS REPORT:

Reported that the County Board of Elections would not charge extra
to Village if we held our elections the same time in a November
Election. We would have to change our election from March to
November either by Resolution or Local Law. If we went to
November Election new officers would start in January.

#### TRUSTEE ASTRY'S REPORT:

Reported that the siren is not working on the Fire Hall. He had
Dennis Pastor take a look at it. The motor burnt out because it does
not have an automatic shut off and manually needs to be shut off
inside firehall. If it is not shut off after 2 to 3 cycles the wires and
motor get very hot and can burn out. The motor has to come down
and be disassembled to take a look at it.

## TRUSTEE FLAHERTY'S REPORT:

- She reported that she researched and found a 4 seater See-Saw for playground at total cost of \$1,153.00 including shipping. Her budget for equipment is only \$1000 and would like to move \$153 from Contractual to cover this.
- She reported that Lily Dale is not going to have any concerts this coming summer on their floating dock. She is going to try to get grants for more concerts in the village.
- She is also going to try to get grants to make beach handicap accessible and to have Picnic Pavilion at beach.

## TRUSTEE SEIBERT'S REPORT:

She reported that she researched lights for Ames Common and compared prices between Rileigh and Holiday Designs and the best deal is with Holiday Designs for 6' lights compared to 5' lights for less money. Holiday Designs is the manufacture of the lights so they can sell for less money. She would like to get 6 lights for total of \$2,650 and have them facing on the inside of Ames Common. The LED lights are \$380 each and shipping is \$370.00. Discussion held that if we purchased 6 now that we would be over budget and not

have money in budget for flowers for Memorial Day. Clerk Astry suggested that we purchase 4 now and 2 after June 1<sup>st</sup> with new budget.
