David and Donna Nichols owners of property of vacant land on Dale Drive (181.20-2-30) offered their property to the Village for \$1.00. This is the property that work had been done by EcoStrategies to alleviate flooding to residents on Dale Drive and Park Avenue. The property could be used as a Fitness Park or anything the Village would like it to be used for. Deputy Mayor Frick stated that it would be discussed further when full board is here.

Historian John Sipos gave us a short history lesson on the Cassadaga Lake Ice Company in which he bought a certificate for 1 share in the company.

Town Supervisor Dave Wilson brought the Shared Service Agreement between the town and village for Code Enforcement and Zoning Enforcement that was signed by Deputy Mayor Jeff Frick. He also stated that the Soil and Water Conservation awarded the Cassadaga Lakes Association with a grant for the lake; \$50,000 will be used to form a Management Plan for Cassadaga Lakes and \$50,000 to dredge the lake.
