MAYOR DORMAN'S REPORT:

Item #1 (Update)

 Local laws review – No change at this time, will be impacted by planning board and subsequent changes to update zoning laws.

Item #2 (Update)

- E-mail from Donna House regarding concern of gravel on Pennington & N. Shore
- Update? Some indication it has been swept back a couple of times.
- Who do we thank for this?
- Likely to be a continuing issue each time there are heavy rains, correct? Agreed.

- Asked by Carol Rasmussen (CCIDA) to meet with the potential buyer(s) of the Kwik Fill business on July 16th. [Bill D. & Bill A. met with them]

- Sales brochure for Radar Speed Signs: share with board
- Thoughts? Looks very expensive for 2 signs.
- Question: Who controls the bicycle signage painted on the bike path? They have faded to a point not very visible any longer.
- Would this help to control speed if more visible?
- Could we add a pedestrian Icon? No, because bikes travel same direction as vehicles while pedestrians are to face traffic.
- Frequency? Suggest as frequently as possible to assure high visibility.
- Does anyone remember if "Complete Streets" addresses speed control? No.

CLERK TREASURER ASTRY REPORT:

- Read Fire Dept. report for June: EMS calls-19, Fire-2, Service-3, MVA-3, Search-1, mutual aid given 11 times with 193 total man hours.
- Our auditor would like us to transfer \$,454.95 to Cash, Reserve for Debt to equal actual. We did not make transfer in 2017.
- Need to transfer \$10,000 from Lake Shore Water Savings to Water checking to pay tonight bills, I transferred \$25,000 on Friday to cover Bond payment. There was enough in our checking account to cover but water portion needed to have transfer.
- Bahgat and Laurito audit for Fiscal Year ending 2019 is completed.
 There was a delay in completion due to Covid 19. It will be shared with board once it is reviewed.
- She will be completing the State Comptroller Annual Audit report on Friday that is due by 30th.

RESOLUTION # 104

APPROVE WATER CASH TRANSFER

Trustee Flaherty moved, second by Trustee Krupa to transfer \$10,000 from Lake Shore Water Savings to Water Cash and approve the transfer of \$25,000 that was transferred on Friday to cover Bond payment. VOTE: 4 AYES, 0 NAYS.

DEPUTY CLERK MAZZONE REPORT: Absent

SUPT. OF PUBLIC WORKS SAM ALAIMO'S REPORT: Absent

- Trustee Astry reported that they have been paving road under Shared Services the last week and half and that Commercial Street in village was paved yesterday.
- There has been an issue with chlorine residual in Lily Dale and they have had to have a Boil Water notice. He has had to flush hydrants on Dale Drive to help alleviate the problem that has caused very dirty water to our water customers on Dale Drive. The main reason for this happening is that the Job Corp has not been using water as normal and the water flow in system has changed. Discussion held that Trustees should be notified when there is a problem so they can answer questions when called.

TRUSTEE ASTRY'S REPORT

 He has spoken to Trudy Coulcher about appointment to ZBA as she is the alternate.

RESOLUTION # 105 APPOINT ZBA MEMEBER

Trustee Astry moved, second by Trustee Krupa to appoint Trudy Coulcher as ZBA member to replace Matt Cassatt term of 2018-2023. VOTE: 4 AYES, 0 NAYS.

TRUSTEE FLAHERTY'S REPORT:

- She reported that we have 6 Chautauqua Work employees helping at beach that normally work at Bethany Camp. She is having them repair and paint picnic tables and Gazebo, raking and will have them paint the Bus Stop. The workers are: Mark Lemay, Hunter Cleland, Micah Helm, Joshua Helm, Owen Sorber, and Tabitha Clark.
- Beach has had 1,512 people in attendance since opening June 27th with average of 59 per day.
- There has been a problem with erosion issues with sand washing into lake when it rains. They are going to try putting sandbags at entrance when it is going to rain.
- The Worship on the Beach has been cancelled for this year.
- Upcoming events are: Ozone Rangers on Floating Stage, Sunday, July 26th, Kayaking July 27th, Zoom Barn dance on August 1st, National Night Out on August 4th, Triathlon on August 5th and Frickin Hot K on august 8th.
- She reported that there will be no Labor Day Parade. They will have a bicycle parade, boat parade, concert, craft show and possible virtual Ducky Derby.

TRUSTEE SEIBERT'S REPORT:

- She reported that she and Clerk Astry interviewed Tammi Wichlacz and Amber Hilliker for cleaning Community Building and office and both were very qualified candidates.
- Reported that Holiday Designs shipped 2 new snowflakes; one will be paid by village and one by CBC. They had been shut down due to Covid 19.
