# CLERK TREASURER ASTRY REPORT

- She reported that Time Warner cable tax total of \$150.21 needs to be abated by Tax Law 626 provides that the amount paid as a franchise fee is to be deducted from the taxes levied on a special franchise.
- We need to decide if we want to apply for ARPA (American Rescue Plan Act) for funds that would be used for infrastructure. At this time, we do not know the amount that the Village would get. The townships are designated a certain amount and we would receive a proportion according to per capita. We need to apply by July 9, 2021 if interested. Discussion held and it was decided to apply.
- We need to decide if as a Village we want to opt-out of allowing retail dispensaries of cannabis or on-site establishment to locate within the village. We would need to pass a local law by 12/31/21 if we were to opt-out. We would not be eligible to receive 4% of tax collected on the sale of adult-use cannabis products. Discussion held and board wanted to look further into this. Attorney Calimeri stated that he would have a proposed local law ready to be introduced for next meeting if we decide to opt-out.
