They understand that they used the water and plan on paying it but was asking if they would not be charged a penalty as they make payments. Clerk Astry explained that the property has had several estimated bills or zero gallons billed because it showed water was shut off. Many have had estimated readings for many cycles so this billing there were a few billings that were very large because of this.
