• She stated that it would be a good idea to have a Representative attend the Chautauqua County Quality Water Board and report back to us. If no one from the board is interested Chuck Battaglia would be willing to attend meetings and report back to board any pertinent information.

RESOLUTION # 30

APPOINT REPRESENTATIVE CHECK BATTAGLIA TO THE CHAUTAUQUA COUNTY QUALITY WATER BOARD

Mayor Lazarony moved to appoint Chuck Battaglia as our Representative to the Chautauqua County Quality Water board, second by Trustee Astry. VOTE: 3 AYES, 0 NAYS.

CLERK-TREASURER ASTRY REPORT:

- She reported that she has begun application for 0% loan to Environmental Facilities and one question was in regards to a SEQR for our Methane Removal Project. She contacted Chatfield Engineers and John Paul Schepp sent his opinion on a SEQR which we will need to make a resolution stating the findings.
- She requested permission to carry one vacation day over that was not used in 2015 for herself.

- She reported that we received report from State Comptroller on village's fiscal stress. The Village of Cassadaga only scored 11.3% on fiscal stress and 25.4% on Environmental Stress. We received the determination that "No Designation" in both categories. A designation is given for anyone who scores above 40%.
- She reported in the absence of Tom Fetter that Fred Holley-Circuit Rider from NY Rural Water Association did a leak detection yesterday on our system. All village streets were tested and all fire hydrants. There were 2 minor leaks on fire hydrants and no leaks in our waterlines. His determination is that our old water meters are not registering all the water usage to our customers. As meters age and the iron and hardness in the water can result in meters slowing down and not calculating all the water used. He recommends a meter change out program. Mayor Lazarony stated that she will look into any grant opportunities.
- She stated that she has to switch Tuesday for Wednesday next week.
- We should be able to finish up budget after meeting and determine tax rate.
