RESOLUTION #65

APPROVAL OF MINUTES

Motion made by Trustee Waite, second by Trustee Dechard to approve the minutes of May 2, 2012. VOTE: 4 AYES, 0 NAYS.

RESOLUTION #66

ACCEPT AGENDA

A Motion was made by Trustee Lehnen, second by Trustee Culverwell to approve the agenda. VOTE: Ayes 4, 0 Nays.

GUESTS: Sheila Kroon, Maple Avenue.

STEARNS & WHELER REPORT: Greg McCorkhill

- He reported that Frey Drilling has leveled area around well site and has temporarily put up orange fencing and it will be replaced with a permanent fence with gate and lock.
- The Hydro geotechnical report came back with no surprises. We will still have to chlorinate and put sequestering agent in the water. The board needs to decide within a month if we want to add fluoride to the water because an injection pump will be needed. Mayor asked for cost of this before any decision is made.
- Met with Bill Boria and Paul Snyder from Department of Health and requested a permit to pump 225 GPM.
- Discussion held on conducting a water pressure flow test. We need to determine cost of this before we decide.

MAYOR LAZARONY'S REPORT:

- The water pit on Dale Drive will be constructed shortly, they have had a difficult time getting a contractor.
- Need to replace meters that aren't working and send letters to those meters that are not accessible.
- She reported that a salesman will be at our June 6th meeting to show us a hand held water meter.

PUBLIC HEARING HELD AT 7:30 ON LOCAL LAW 1 OF 2012 REGULATING UNCONTROLLED WEEDS AND VEGETATION.

The mayor read the Findings and Determination and briefly went over the major parts of the proposed law. Sheila Kroon was the only attendant who

addressed the board. Trustee Lehnen objects to the law that grass only has to be 6 inches before someone is given notice, feels this is too short. Roxanne Astry voiced her objection as a community resident, she feels that it is a little harsh that someone could be put in jail up to 15 days and fined \$250 for not mowing their grass.

- She reported that she was called for Jury Duty for Friday, May 18th.
- She will be attending a Tax Collection class in Mayville at 1PM on May 22nd to find out how to use their tax collection software. There is no cost and Deputy Clerk Joan Josephson will attend also.
