Cara Seekings stated that she would like water to stay fluoride free. Barbara Sarson is concerned about fluoride.

Margaret Ferris is not in favor of fluoride and wanted to know the name of it.

Rudy Abersold is opposed to adding fluoride and board should be concerned about quality of water and improving the system. The public should be allowed to decide if they want to add fluoride in other form. Bob Reuther thanked the board in bringing in experts at last meeting. It should be left up to the individual if they want to take fluoride. Emmy Chetkin is opposed to adding fluoride to system and concerned

about possible side effects and feels it is not necessary.

Ellen Morse is a Nurse Practitioner and stated when a drug is given that her patients have to give consent.

George Mayer feels that water customers should be given choice to decide. Terry Mayer agrees with what everyone has stated and feels it is not necessary.
