RESOLUTION # 125 APPROVAL OF MINUTES

A motion was made by Trustee Wilson second by Trustee Flaherty to approve the minutes of August 25, 2021. VOTE: 3 AYES, O NAYS

RESOLUTION # 126 APPROVAL OF AGENDA

A motion was made by Trustee Flaherty, second by Trustee Wilson to approve the agenda. VOTE: 3 AYES, 0 NAYS.

GUESTS: Historian John Sipos, 5 Pennington, and Chairman of Planning Board, Nancy Wickmark.

Historian John Sipos commented that the Labor Day Parade was excellent, and Sue Asquith did a wonderful job as chairman. He recommends that she does it next year. The entire weekend was wonderful and very busy.

Planning Board Chairman Nancy Wickmark gave status update report of a 6 month review of Action Items. The Zoning Law committee will be starting meetings again soon and she will make recommendations on aligning the Comprehensive Plan with zoning revisions.

The 30 MPH signs that were put up on Dale Drive and Frisbee worked out well and would like to see more distributed. Rodney Waite purchased them and put them up. Deputy Mayor stated that we are looking into that.

She would like to see the Village purchase a MPH sign devise showing speed limit of cars going by.

There still is an opening for a Planning Board member and would like to see a young person appointed if possible.

ATTORNEY JOSEPH CALIMERI'S REPORT:

- The closing on the property transfer to Kei Ping Yueng was finalized and needs the mayor's signature.
- Reported that the Town of Pomfret has approved contractor for the waterline replacement in Lily Dale.

MAYOR DORMANS REPORT: Absent

CLERK TREASURER ASTRY REPORT

- Read the CVFD report for August as follows: EMS-20, MVA-3, alarm activations-6, standby-1, landing zone-1, odor investigation-1, M/A given-17, M/A received-1. Total calls-32, Total manhours-98.35.
- Read Public Notice from Town of Pomfret about public hearing on solar modules and inverters at 8052 Route 60 owned by Thomas Peck.
- Reported that Chris Doyle from NOCO who supplies the villages gas and electric recommends that we consider changing our gas bills from variable to fixed. The costs are going up at a fast rate and thinks that we will do better changing it to an 18 month fixed rate -\$0.595/ccf. The current variable rate today is \$0.595/ccf. This would get us through the next 2 winters.
- Reported that Governor Hochul gave executive order that allows Public Meetings can be held remotely again due to rise in COVID cases.
